- 1. Visit College website <u>http://www.islamiacollege.edu.in</u> and navigate to submit the admission form link.
- 2. Enter Roll No. against which the candidate is selected and submit the online fom and make payment of prescribed programme fee online using Internet payment methods such as Credit Card/Net-Banking etc through College website only
- 3. Hard copies of the online submitted forms alongwith fee paid receipt are to be submitted with the Admission Section of the College alongwith following documents:-

- Provisional-Cum-Character Certificate from the institution last attended (in original only)
- Transcript card of Degree
- Two copies of fee receipt.
  The candidates need to submit the above mentioned testimonials / certificates in original and two self attested photocopies.
- 4. The window of admission for selection list No. 01 will remain open from 02<sup>nd</sup> of September 2024 to 06<sup>th</sup> of September 2024 upto 4:00 p.m.
- 5. Those of the candidates who fail or miss to complete the admission formalities within the stipulated time shall cease their chance of admission in the programme and no request or application whatsoever shall be entertained in this regard. The vacancy thus created shall be offered to the next candidate as per merit.
- 6. The admission to the programme is purely on provisional basis and is subject to the verification of the documents/certificates to be submitted by the candidates.
- 7. Any document(s)/Certificate(s) found false/tempered/forged etc., the selection of the candidate shall be cancelled and legal action under rules shall follow.
- 8. In case of admission on the basis of category under-process certificate in the office of the competent authority shall in no case be considered. The admission of such candidates will be cancelled without any notice.
- 9. Mere downloading of the admission form and keeping the same without fulfilling the required formalities as listed above, shall not be deemed/considered for admission to the P.G. programme.
