- The Contractors / bidders should upload a scanned copy of E.M.D. Rs.10,000/- in form of CDR/ FDR online, valid for period of six month pledged to the Accounts officer, Islamia College, Srinagar.
- The Bidder shall upload scanned copy of PAN Card.

- The bidder can inspect the site before bid submission dates (during working hours). The auction of the earth value will be *as is and where is basis* and the bidder cannot claim for any extra remuneration for the job.

The bidder should carry out the job within the given time limit at his own risk and cost and with all safety provisions required for the job.
